developed by Jabra has been certified for usage with following: Atos Unify OpenScape UC Desktop App in accordance with the respective test report, dated January 23<sup>rd</sup>, 2023. Based on the similarity statement from Jabra both variants Mono and Stereo are certified by testing only one of them.

The test was conducted conforming to DIN EN ISO 9001. This certificate is only valid in conjunction with the full test report and the notes contained therein. The supplier of the certified product confirmed in their declaration of conformity that the product is in line with all compliance regulations (e.g. "acoustic shock") and is responsible to perform appropriate acoustical tests for the mentioned products via the relevant interfaces. Please consider that the test report only covers the functionality of the interface. The certificate and test report are not good for a statement of end-to-end functionality.

It is hereby declared:

Jabra Engage 40 UC headsets are available in Stereo and Mono versions and each version is also available with either USB-A or USB-C connectivity. Users can choose versions with built-in (inline) controllers, or choose to have headsets without controls. The versions with controllers are identified as “Inline Link” in the product descriptions.


In every case, the headsets support USB connection to a PC running a soft client such as Unify OpenScape UC. The headsets with inline controls support standard call controls, including answer, end and mute, and have volume controls. Controllers also have two additional buttons, one of which is used to manually toggle the headset busy light on or off. The other button has no assigned function in the out-of-box state, but can be configured through the Jabra Direct application, or via an integration of the Jabra SDK in third-party software.

All Engage 40 headsets use identical firmware.

When connected via USB to a PC running Unify OpenScape UC or similar, functional behavior of all Engage 40 headsets is identical.

The mono and stereo headsets for Engage 40 are the same and as such, except for the difference inherent in mono and stereo products, there will be no other difference in audio performance between the models.
